2019 was a milestone year for PALS Autism Society. The dream of opening a specialized school for children struggling with the challenges of autism became a reality in 2007. However, the facility we occupied had constant challenges. The dream of owning a school property became a reality in 2019. The perseverance and expertise of the Board of Directors of PALS coupled with strategic and successful negotiations resulted in the purchase of a home for PALS in New Westminster. The dream of educating the students in an authentic school environment finally materialized.

Also, 2019 was a year of successes for the adults of PALS Autism Society. The program expanded to address the long waitlist and increased the number of paid and volunteer work opportunities in the community by attracting inclusive employers to the benefits of employing adults with autism. The Social Enterprise increased its product offerings enabling more opportunities for work training and sales. One of the future goals of the program is to develop housing opportunities for adults struggling with the challenges of autism.

On behalf of the board of PALS Autism Society, I would like to thank the committed staff of PALS for their ongoing work to educate and support the students. Also, gratitude to all the volunteers who dedicate timeless hours to help grow our society. A million thanks to our foundations, corporate and private donors who have shared our belief and supported us in changing lives for our students and their families.

Looking ahead, the need for support is ongoing. Fundraising goals have to be met and budget restrictions adhered. This is only possible with the help of our donors and the community. Thank you for helping us change lives.

A MESSAGE FROM THE HEAD OF ADULT PROGRAM KARIN TERADO

In 2019 the adult program welcomed four new young adults for a total of 31 part time and full time participants as we continue to develop our on-site and community-based programs. New classes, such as a computer coding class, mapping/discovery class and performing arts (dance/boot camp and drama) enrich the program curriculum, and new employers have been added to our roster. The employment programs are composed of volunteer, paid and social enterprise positions that include work with 19 local neighbourhood houses and community centres, grocery stores, health authorities, arts organizations and high-tech industries, to name but a few. 20 of the young adults who attend the program have community-based employment, 15 volunteer on a weekly basis, 9 are paid employees of the Social Enterprise and 6 are paid by their community employers.

PALS Social Enterprise continues to grow its product line. In addition to its popular, quality, hand-crafted candles, PALS Social Enterprise now offers Aromatherapy Atomizers in either eucalyptus or pine, Beeswax Wraps (in 3 different sizes) for an eco-friendly option to plastic food wrap, and Basil Infused Premium Olive Oil. And, as with our candles, the young adults who attend the program make, prepare and package all of the social enterprise products.

A MESSAGE FROM THE HEAD OF SCHOOL ANDREA KASUNIC

After 12 years of operating out of a small office building in East Vancouver, PALS Autism School purchased and moved into a large heritage house in New Westminster in March 2019. Over a period of 5 days, staff and families worked tirelessly to pack, unpack, and settle in so the students could walk into class on Monday morning and feel at 'home'. One common characteristic of autism is resistance to change in routine, so imagine our surprise when the students' reactions were entirely positive. Their new commutes, new classrooms, and new playground did not go unnoticed; however, these were all a welcome change.



The extra space was just what we needed, and the new programs we are able to provide as a result are game changing. Students have more opportunities to learn practical life skills such as cooking on a stovetop, doing laundry, and making a bed. They have more opportunities for physical exercise such as using scooters around the neighborhood, playing basketball on the playground, and finishing a 9 station gym circuit complete with an elliptical machine, treadmill and recumbent bike. Academics and 1:1 classes can be completed in quieter areas, and we

finally have a dedicated room for parent meetings and staff resources. The City of New Westminster has been very welcoming, and we have secured 3 new volunteer work placements for our Student Transition Program. We look forward to having even more placements at local businesses by the end of the year.

The School Program recently completed a Monitoring Inspection by the Ministry of Education. I am pleased to report we passed again with flying colours. All of our policies, procedures, student records, staff files, special education budget, building maintenance, and teaching practices are in compliance with the expectations of the Ministry of Education.

There is strong interest in the PALS educational model from other professionals who want to visit the school and learn what we do. Furthermore, we continue to build partnerships with new foundations and nurture existing ones by welcoming donors to visit the school.

I extend my deepest appreciation to all of our donors, supporters, families, staff, volunteers, and board members for being an integral part of making this major milestone possible.




A MESSAGE FROM THE TREASURER (CONTINUED)

You will see a slight increase in facility expenditures from the prior year as both adult and school programs moved during this fiscal year.

This past May, a new Society called PALS Adult Services Society (PASS) was incorporated and is currently awaiting approval of its registered charity status. Once obtained, the adult program and its related committees will transfer to PASS. PALS Autism Society (PALS) will continue to oversee the school and before and after school programming. The separation into two Societies is a positive sign of our growth, which is needed as the adult program plans to expand its day programming into Housing and Respite services.

The financial and emotional burden of raising a child with autism is a fact of daily life for PALS families. School or adult program fees can become prohibitive for some of our single parent families, single income families, or lower income families. PALS would like to extend our sincerest appreciation to the **Canucks for Kids Fund** and **The Morris & Helen Belkin Foundation** for providing support for PALS students and young adults and their families through their commitment to the PALS Tuition Bursary Fund for the School Program and the Adult Program respectively.

This year the **Burnaby Firefighters Charitable Society In Memory of Alan and Marilyn Codyre** doubled their 10 year annual commitment to PALS Autism School, with an extension of their annual pledge to 20 years! Their donation will be allocated to the PALS Tuition Bursary Fund and the PALS Year 13 Bursary Fund. The Year 13 Bursary Fund assists Grade 12 special needs designated students to attend the school program for an additional year. The British Columbia Government has made all Grade 12 special needs students eligible to attend secondary school programs up to the age of 21, however Provincial funding is reduced for students attending PALS beyond the age of 19.

The PALS Before and After School Care Program is a critical lifeline for our families who require out of school care to continue their child's enrollment in the school program. PALS Autism Society would like to extend our appreciation to **The Wolrige Foundation** and the **Diamond Foundation** for helping families access an affordable Before and After School Program at PALS this year.

In March 2019 PALS Autism School relocated to its new home in New Westminster. Although the building was previously used as a school, considerable costs were incurred to adapt the premises for students with autism. We are tremendously grateful to **Corix Water Products** – **Golf for Kids** for providing proceeds from their annual golf tournament to help offset both the school relocation and building adaptation costs. We would also like to thank the **Raymond James Canada Foundation** for their donation which was used to help offset costs of the school move to New Westminster.

The Sutton Place Hotel Vancouver has generously continued their support for PALS by hosting multiple philanthropic activities benefitting the Society. They bring autism awareness to our community while fundraising for PALS Enriched Summer School program through their Diamond Level Sponsorship at the PALS Gala, proceeds from their Annual Just "Fore" Fun Golf Tournament, and their Annual "Home for the Holidays" Christmas tree decorating event. PALS summer programs offer recreational, therapeutic and community-oriented activities although no funding from the Ministry of Education is available to help subsidize the cost. Year-round programming is a necessity for students with autism. By maintaining a year-round program, PALS minimizes the risk of student regression, which commonly occurs during extended school breaks. This allows parents to continue working throughout the summer months, knowing that their children are in a safe, nurturing, and appropriate educational environment. Unfortunately, the Lower Mainland offers very limited, affordable summer camps or childcare placements for children with autism. We are so very grateful for our partnership with The Sutton Place Hotel Vancouver and their support for PALS school students throughout the years.

PALS Autism Society would like to recognize and thank our newest benefactor, **CCSF Autism Foundation** for their generous donations to the school program and their desire to generate increased community awareness of the urgent needs of children living with autism.
